Attached is our suggested response to Mr. Tenorio. We have chosen to avoid directly addressing many of the concerns expressed in his letter because he, as he often does, voices views which are in conflict with the position of other officials in his government, particularly the Governor of the Northern Mariana Islands. He has formally taken the position that as the elected "Resident Representative to the United States", he is the only official authorized to speak for his Government in dealing with the United States.

Therefore, I feel this draft adequately responds to his letter.
